**CLASS FEES:**

**Pre-Entry Fees:** \$20.00/class or \$100.00 unlimited classes **Deadline date: July 15, 2008**

**After pre-entry deadline:** \$30.00/class or \$150.00 unlimited classes

**STALLS FEES:** No Phone Reservations. Only one animal/stall. All horses kept on grounds overnight must be stalled.

**Pre-Entry Fees:** \$16.00/night or \$45.00 /weekend **Deadline date: July 15, 2008**

**After Pre-Entry deadline:** \$20.00/night or \$55.00/weekend

**TRAILER IN FEE:** \$10.00/DAY Trailer in fee if showing out of trailer on a daily basis

**OFFICE FEE:** \$3.00 per horse per class – showing 4 classes or less

OR \$15.00 per horse showing 5 or more classes.

**PtHA FEE:** \$8.00/horse plus \$4.00/class

**CAMPING FEE:** \$16.00/night or \$45.00/weekend

**OTHER FEES:** Returned Check Fee: \$25.00 per returned check. If payment is not made within 30 days of notification the NSF check may be turned over to PtHA for disciplinary action.

**PRE-ENTRIES:** Must include the following to be considered and be postmarked by July 15, 2008.

1. PtHA Master form & Jubilee Pre-Entry form (must be filled out completely) with photocopies of 2008 negative Coggins test, all registration papers (front & back), current PtHA membership card for each listed owner, each listed lessee and each open, amateur or youth exhibitor. Novice youth or amateur notation must appear on the membership card in order to enter novice classes. Also, family relationship forms and leases must be on file with PtHA and a copy must be provided with pre-entry.
2. Check made payable to ECPJ **ALL FEES TO BE PAID IN U.S. FUNDS ONLY.**

**MAKING ENTRIES AT THE SHOW**

1. Refer to the Pre-Entry List for at show entries materials. If you do not have all applicable membership cards with you, you must purchase them at the show, as PtHA requires.
2. At-show entries must be added at least 5 classes prior to the class being entered. No entries will be accepted until ALL fees are paid. Post-entry fees will be charged for added classes unless the horse is pre-entered for unlimited classes.
3. Once an exhibitor has cancelled a class he/she may not re-enter that same class.

**REFUND POLICY:**

1. Full refund for pre-entries if cancelled by 9PM Wednesday prior to show. Call Betty Dennis to cancel.
2. To receive a refund after the show begins an entry must be cancelled at least 5 classes prior to the class being cancelled. The \$15.00 office fee and \$8.00 PtHA/horse fee will not be refunded for cancellations after the show has begun.

**ADDITIONAL INFORMATION:**

1. Rules for this show are those of the current National PtHA Rulebook.
2. Stallions may be shown only by exhibitors 19 or older.
3. **If classes that cannot be combined have fewer than three entries, they will be run as non-ROM point earning classes. All published class fees will be assessed. Exhibitors choosing to withdraw must do so five classes prior in order to be eligible for a refund. If there are no entries the class will be cancelled.**
4. **Classes with 3 or more entries will run as listed on the showbill unless combined with a smaller class.**
5. Leash Law: Michigan law requires that all dogs must be on a 6' leash during the day and kept inside at night. Violators will be reported to the local Police who will deal directly with the problem. Please clean up after your dog in the arena and office area.
6. There will be a food vendor on the grounds.
7. Michigan law requires horses to have a negative Coggins test within the calendar year.
8. **No horses or exhibitors will be allowed on the grounds before noon of the day before the show.**
9. **TWO MINUTE GATE RULE:** The two-minute class entry time begins when the first horse of the class enters the arena.
10. **NO LEASES CAN BE PURCHASED AT THE SHOW.** All amateur and youth exhibitors must own or lease their horse.
11. All Minis & Ponies must be measured by show official or produce a current PtHA measurement card before entering classes.
12. By entering this show, owners, lessees and exhibitors agree that PtHA, the five sponsoring charters, the show committee and the show grounds will not be held responsible for any loss, injury, damage or debts in connection with this show.
